Grants Guidelines Small Grants Program 2019

Highways and Byways is a new Public Benevolent Institution established by the Missionary Sisters of Service (MSS) to carry on the work of The John Wallis Foundation, and to further develop the reach and capacity to support disadvantaged communities, particularly in rural and remote areas of Australia.

Since 1944 the MSS have travelled vast distances to reach people in all kinds of places and situations, and support those on the margins: geographically, culturally, spiritually, socially and economically.

In 2019 the MSS are celebrating 75 years since they were founded in Tasmania by Fr John Wallis. To acknowledge this, the 2019 Grants program will seek applications from organisations in the areas where the MSS sisters have lived and worked over the last 75 years, especially rural and regional areas.

Highways and Byways 2019 Small Grants Program Focus

Background: The focus for the **2019 Small Grants program** is influenced by the findings of the recent Poverty in Australia 2018 report by the Australian Council of Social Service, and also by the teachings of Pope Francis in relation to inter-generational bonding and skill sharing.

Catholic Social Justice principles also inform the work and decisions of Highways and Byways. We are guided by principles of: the dignity of each person, the common good, the right of all people to participate in decisions that affect their lives, solidarity, preferential care for those who are poor and vulnerable, economic justice, stewardship of creation and promotion of peace.

Focus: Women Addressing Disadvantage through the sharing of skills across generations

This year our focus is on initiatives which benefit women and girls. Over the last five years in reviewing our grants programs, we have seen time and again powerful demonstrations of women working together to build strong communities through capacity building and the sharing of skills **across generations**. We are excited to offer communities further support to build on this important work.

Highways and Byways welcomes applications that assist people and communities to address disadvantage and inequality particularly **in rural, regional and remote areas of Australia.** We are keen to support projects which address disadvantage through embracing the potential of local women to develop skills, confidence, capacities and leadership between generations and within their communities.

Funding and Location Criteria

Highways and Byways does not fund individuals. We are able to fund community groups or organisations which can demonstrate that they are at minimum an Incorporated Association or similarly constituted entity.

Projects need to demonstrate that they are addressing the relief of social and economic distress, and geographical disadvantage, through locally led action.

Projects are to be completed within 12 months unless otherwise negotiated. Generally grants allocated are up to \$3,000.
